### **Additional Comments**

- A. Mr. Robertson suggested to the Board that the new member fee be increased to \$30, which would include \$25 for state dues and \$5 for Zebra-Ware scheduling fee. The Board approved the request.
- B. Mr. Petty indicated that there will be a charge in the future to use the CHP classroom to conduct membership meetings. The charge will be \$50 per hour. However, ASU will waive the fee if the Chapter will waive local dues of the ASU students who officiate. Since the ASU students pay fees which subsidize facility use on campus, ASU felt that the students would receive benefit from the training location on campus. The ASU students would pay the state dues of \$50, a \$5 Zebra-Ware scheduling fee, and any additional fees (ex. Scrimmage rider's fee) or fines that the Board assesses to each member. The \$30 local dues would be waived. Mr. Petty moved to waive the fees of the ASU students in the chapter. Mr. Long seconded. The motion passed unanimously.
- C. Mr. Robertson suggested the following By-Laws changes. By-Law revisions will need to be read to the membership two times before the vote.
  - i. It is becoming a tremendous task to keep record of everyone's reason why they plan to miss the membership meeting. Therefore, Mr. Robertson suggests that the chapter eliminate the requirement for the members to contact the Secretary or Treasurer if they plan to miss. Also, create a single fee of \$2 that will be charged to each member who missed the membership meeting regardless of reason, except if that member is scheduled by the Chapter to officiate football the night of the meeting.
  - ii. Mr. Robertson feels that the membership began meeting too early during the 2008 season. Many people did not attend due to vacation, not back from school, or other reasons. Therefore, Mr. Robertson suggested that the first membership meeting date should be moved to the first Monday in July instead of June.

Mr. Wilson moved to adjourn. Mr. Long seconded the motion. The motion passed unanimously.
