## **Elections On-Line with Zebra-Ware (BP)**

• Mr. Petty stated that Zebra-Ware has a function which allows us to conduct elections online. Mr. Petty and Mr. Walker suggested that the regular election process needs to remain the same; however, it might be possible to use the online voting process with the absentee ballots. In the past, the President appointed an Elections Chair who collected all absentee ballots by having the member fax the ballot to the Chair by a certain deadline. Mr. Petty stated that he is checking to see if Zebra-Ware will allow us to have an Elections Chair who would be the only individual who could see the absentee voting results. All the member would have to do is log into Zebra-Ware and submit their vote instead of faxing the ballot to the Chair.
