 - 2. The wing officials should punch backward once they have determined the pass is backward. The official on the side in the direction the pass was thrown will punch backward, not the off-official.

Game Assignments

- Mr. Petty reviewed the 4/5A Officials Crews Selection Process
 - According to Coach Brent Davis, the new district policy for 5A crew selection is that three crews will be selected by the home chapter with mutual agreement by the home coach. Therefore, only 15 total officials will be selected to officiate all 5A home games.
