# **Proposed NCAA Rule Changes**

- Mr. Petty reported that there were three potential major rule changes for the NCAA Rulebook:
  - Clock status on Out-of-Bounds Plays: The clock will be started on the ready-forpay whistle following a run out-of-bounds except for the final two minutes of the second and fourth quarters.
  - Sideline Enforcement: There will be no more sideline warnings. The new enforcement will be on the first infraction, 5 yards; second infraction, 5 yards; and third and following infractions; 15 yards. All fouls will be Sideline Interference.
  - Facemask Fouls: All facemask fouls, offense or defense, will be a 15-yard penalty. No more 5 yard facemask fouls. (CLOSED)

## **Coaches Meeting**

 Mr. Petty reported he sent an e-mail to all coaches indicating that the San Angelo Football Officials Board would like to meet with all head coaches to review scheduling, payment issues, new rules, scrimmage formats, etc. He received no response from any coach. The Board decided to cancel the meeting. (CLOSED)

## Game Assignments

- Mr. Petty submitted the following to the Board:
  - I. 4A/5A List
    - A. Mr. Petty requested that all Board members complete an officials' evaluation indicated the highest level of game that each official could officiate. This list will determine the 4A/5A Lottery.

    - A. Lakeview and Central will select the crew chiefs for each of their home games. Then, the crew chiefs selected for the games will select their crews from the lottery.

If the Secretary schedules someone for a playoff game who did not attend either of these meetings, TASO will place the Secretary on suspension. (CLOSED)
