#### **Financial Report**

- Mr. Robertson distributed and reviewed the 2010 budget.
- A copy of the budget will be distributed to the general membership tonight.

## **State Meeting Update**

- Mr. Walker indicated that the chapter would use the 2009-2010 payment fee schedule for the 2010-2011 season due to litigation.
- Travel would be calculated by the state rate determined on September 1, 2010.
- Members of our chapter will need to register with TAPPS in order to officiate play-offs.
- Members should complete the exam on the TASO website before Thursday, August 19. There is no deadline for new officials. Members must make at least a 70% to officiate varsity games. Officials will be rated on their best score, not the last score.
- San Angelo was quested regarding their insufficient number of 2009 End of Year Summaries that were provided to TASO. Twenty-one officials did not submit the summary. It is the responsibility of each official to submit an End of Year Summary each year.
- TASO's database (Intrafocus) will be eliminated, and a new software will be utilized during the Fall.
- Elections will be conducted for TASO State Board Officers from October 4 through October 18 on the TASO website.
- Mr. Walker indicated that the chapter would need to officially nominate him to serve as
  District II Director beginning in 2011. Mr. Petty moved to nominate Mr. Walker to serve
  as District II Director beginning in 2001. Mr. Robertson seconded. Nominations were
  closed. Mr. Petty will draft a letter to the TASO State Board nominating Mr. Walker.
  This letter will be signed by the SAFOA Board next week.
- Mr. Long indicated that the court directed the insurance agency to pay restitution in the amount of \$50,000 to each official, \$145,000 in lawyer fees, and \$8,900 in court costs to finalize the San Antonio lawsuit.

- Mr. Minton and Mr. Long reviewed the new rules for 2010. Officials should utilize 2009 rules with a few exceptions that can be found on sazebra.org.
