### Additional Comments

- TASO State Meeting is scheduled for August 2 through 4 in the Irving Convention Center.
- Mr. Robertson reviewed the new Section 1204 mileage from the UIL. Each chapter should identify what travel guideline (i.e. metro or non-metro) they would like to use and notify TASO. Mr. Robertson suggested that the non-metro would be the most beneficial for our chapter. Mr. Wilson moved to adopt the non-metro plan for the 2013 season. Mr. Gober seconded. The motion pass unanimously (CLOSED).
- Mr. Harris stated that he believes the new meal allowance has been reduced to 150 miles round-trip. Mr. Petty researched the meal allocation. According to the new Section 1204, "Schools shall not pay for any meals for officials unless the distance traveled round trip from the official's home to the game site is greater than 150 miles. If meals are paid, the amount is \$15 during the regular season and \$30 during playoffs."

- Mr. Wilson inquired about a gift to memorialize Mr. Long's fathers passing. Mr. Robertson indicated that the Board typically gives approximately \$50 for the passing of a member's family passing. He would submit the gift for the Chapter in the manner Mr. Long prescribes. (OPEN)
