**Board Meeting Minutes – Draft**

**New Business:**

**Standing Committees**

- On-the-Field Clinic
  - The clinic was approved by Mr. Mark Baker for Saturday, August 9 from 7:30 a.m. to 12:00 p.m. at San Angelo Stadium.
  - Mr. Harris indicated that his daughter no longer works for Stripes; therefore, he might be able to secure drinks for the clinic.
  - Mr. Petty stated that we should purchase small drinks and fruit like we did last year.
  - Mr. Purcell agreed that he would assist with securing items needed for the clinic.
  - The board discussed the possibility of needing five individuals to serve as players during the clinic. Mr. Petty indicated that we have used GAFB personnel in the past. Mr. Robertson indicated that he would help secure personnel if needed.

**Financial Report**

- 2014 Budget
  - Mr. Robertson indicated there are no changes for the chapter finances.
  - Mr. Robertson provided a 2014 budget proposal for the board to review. The proposal showed a surplus of approximately \$400.00. The board suggested that we use those funds to reimburse Dr. Dutton for travel expenses to attend the state meeting since Mr. Gober and Mr. Petty would not be able to attend. Mr. Purcell moved to use the President/Secretary stipend to reimburse Dr. Dutton for state travel expenses. Mr. West seconded. The motion passed unanimously. Mr. Petty stated that he would inform Dr. Dutton of the reimbursement.

**Background Checks**
