**Board Meeting Minutes – Approved 8-8-11**

**Financial Report**

- Mr. Robertson requested a Board recommendation for members who are unable to officiate the entire season but have paid state and local dues (e.g. illness, injury, personal reasons, etc.). After discussion, Mr. Colston moved that the Board should approve the Treasurer to apply credit for local dues paid to the subsequent year for members in good standing if the official did not receive payment for any assignment. Mr. Dubois seconded the motion. The motion passed unanimously. As a point of clarification, this only applies to local dues. State renewals or reinstatements must be paid by each official and submitted to the state each year. Also, this relates to any game assignment where payment is received (i.e. varsity, sub varsity, timers, and chain crews). The intent of the Board is to apply local dues credit to officials who were unable to reap the benefits of game assignments. (CLOSED)

**Officials' Uniform Requirement**

- Mr. Petty informed the Board of the results of the membership vote for uniform requirements. The question posed to the chapter was, "Are you in favor of wearing only black pants for Varsity and JV games?" Results: Yes – 28; No – 11. Therefore, the chapter uniform for Varsity and JV games will include black pants with black socks. White knickers will no longer be worn during any Varsity or Sub Varsity contest. Members are encouraged to purchase black pants as soon as possible. (CLOSED)
