# San Angelo Football Officials' Association Monday, September 18, 2007 <br> Board Meeting Minutes - Approved 9-25-07

- Mr. Walker informed the Board that he would like the membership to submit all By-Laws revisions to the Board by Monday, September 24, 2007. On Monday, September 24, 2007, the Board will conduct a By-Laws review workshop and discuss the proposed ByLaw changes. The Board will submit the recommended changes to the membership by mid October. The membership will vote on the proposed changes at the general membership election in November. (OPEN)


## Chapter Shirts

- Mr. Dan Robertson was directed by the Board to investigate the purchase of Chapter Polos for members to wear for Varsity and Local, Regional, and State Meetings. Mr. Robertson presented a variety of shirts for the Board to select from. Also, a logo was
designed for the Chapter. Mr. Robertson indicated that Total Sports was the best vendor in town to have the polos made due to the shortest timeline and lowest cost. The polos will cost $\$ 25.50$ per shirt. The polos can be completed within the week. Additional polos can be purchased at a later date for individuals who cannot pay for them at this time. Mr. Long questioned whether or not the Chapter should pay for the shirts for the members. The Board agreed that each person should be responsible for purchasing their own shirt. Mr. Long moved to provide an opportunity for our members to buy a Chapter Polo. Mr. Martinez seconded. Motion passed unanimously. ## 4 Person Mechanics for 6-Man and 11-Man

- The Board clarified the 4 person mechanics for 6-Man and 11-Man games.
o 6-Man
- During Free Kick, the U/BJ will be on the kicking teams' restraining line on press box side. The HL will be on the receiving teams' restraining line opposite press box. The R/LJ will be back deep with the receivers.
- U/BJ will act as a BJ during punts. They will be back with the deepest receiver.
- During field goal attempts and kick trys, the LJ/BJ will be under the uprights. R will have the kicker and holder. HL will have the players on the line of scrimmage.
o 11-Man
- During Free Kick, the $U$ will be on the kicking teams' restraining line on press box side. The HL will be on the receiving teams' restraining line opposite press box. The R/LJ will be back deep with the receivers.
- LJ will be back with the deepest receiver before the snap.
- During field goal attempts and kick trys, the LJ will be under the uprights. R will have the upright opposite the LJ. HL will watch kicker and holder. U will have the players on the line of scrimmage. (CLOSED)


## 6-Man Snapper Rule and Overtime Rules

- Mr. Petty indicated that several coaches questioned the rule regarding protection for the snapper during scrimmage plays. Mr. Walker reported that the snapper is provided onesecond protection during scrimmage kick formation plays only. Mr. Petty also questioned overtime rules for 6-man games. Mr. Walker reported that all overtime rules are the same except that the teams are not required to go for two points during a try in the third and subsequent overtime. (CLOSED)
