Financial Report

- Mr. Robertson reported that he deposited \$2,100 from scrimmage fees and late membership dues.
- Mr. Robertson reported that he received payment of \$132 from Bill Hollis for 2007 and 2008 missed meeting fines.
- Mr. Robertson stated that he will collect the 2009 missed meeting fines along with the 2010 membership dues beginning October 12, 2009.

2010 Membership Dues

- Mr. Walker reviewed the current SAFOA membership dues structure and opened the floor for suggestions for revisions. Mr. Petty stated that with the passing of the stipend for the Secretary and Treasurer, an increase of \$15 would be needed to maintain a Zero Based budget. Mr. Wilson moved, Mr. Page seconded, the following dues structure be implemented for the 2010 season:

 - o Reinstatement on or after January 1: \$160 (\$75 State dues and \$85 Local dues)
 - Auxiliary: \$30 (\$25 State dues and \$5 Local dues)
 - ASU Students: \$70 (\$50 State dues and \$20 Local dues)
- The motion for the new dues structure passed unanimously.

- The questions for Quiz 7 on September 28 will be taken from Rule 7, Section 1, FR-95 through FR-100.
- Mr. Petty stated that he would suggest several By-Law revisions:
 - A. Revise the By-Laws to read, "Any Board member may receive as remuneration for services performed an annual fee to be determined by the Board, except for the initial fee, which shall be recommended by the Board and approved by a majority of the Members of the SAFOA. Any increase or decrease shall not

- exceed five percent (5%) from the previous year, unless approved by a majority of the membership of the SAFOA."
- B. Revise the By-Laws to read, "Members who have accepted games shall pay the following fines for game turn-backs:
 - A fine of \$5 shall be levied for a game turned back within 7 days of the game.
 - A fine of \$10 shall be levied for a game turned back within 48 hours of the game.
 - A fine of \$20 shall be levied for a game turned back within 24 hours of the game.
 - A fine equivalent of the game fee(s) missed shall be levied for a no-show.
 - Exceptions can only be approved by the Board of Directors and shall only be approved for verifiable emergency situations.

Mr. Long moved to adjourn. Mr. Wilson seconded the motion. The motion passed unanimously.
