

**San Angelo Football Officials' Association**  
**Monday, September 8, 2008**  
**Board Meeting Minutes – Approved 9-15-08**

Mr. Walker called the meeting to order at 5:36 p.m. at the ASU Center for Human Performance Conference Room.

**New Business:**

**Standing Committees**

**Financial Report**

- Mr. Robertson reported that he sent the scrimmage invoices to the schools that had scrimmages. He has received approximately 14 out of 21 payments from the schools. Mr. Robertson stated that some schools are asking him to complete a W-9 in order to receive scrimmage fees, where the Association's tax id number is required. He stated that Mr. Petty e-mail Mr. Greg Swindle regarding the number but received no response. Therefore, Mr. Robertson contacted Mr. Alan Jones. Mr. Jones stated that he was unaware of a tax id number for the Association; however, he suggested that Mr. Robertson contact the bank where we have a checking account. Mr. Robertson stated that he contacted the bank, and we do have a tax id number. Mr. Walker inquired about whether the tax id number is the same as a tax exempt number. Mr. Robertson indicated that he believes it is not the same number. Mr. Petty stated that we would only use a tax exempt number if we purchased supplies for the chapter. Mr. Long stated that we would also need the tax exempt number for the scrimmage fees collected because the schools might withhold taxes from the fee.
- Mr. Robertson reported that some schools are requiring officials to complete a W-9 before they receive payment.
- Mr. Robertson reported that he has scrimmage driver's fees for Mr. Steve Wilson and Mr. Jose Green, which he will distribute tonight.
